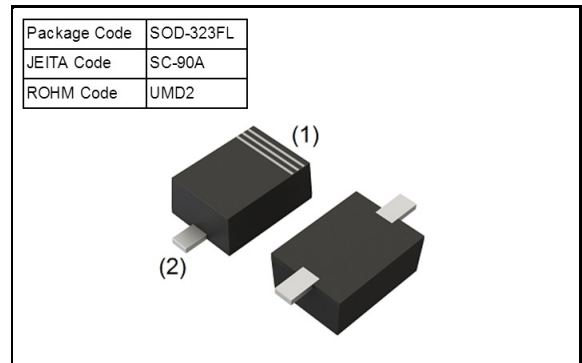

#### Attention

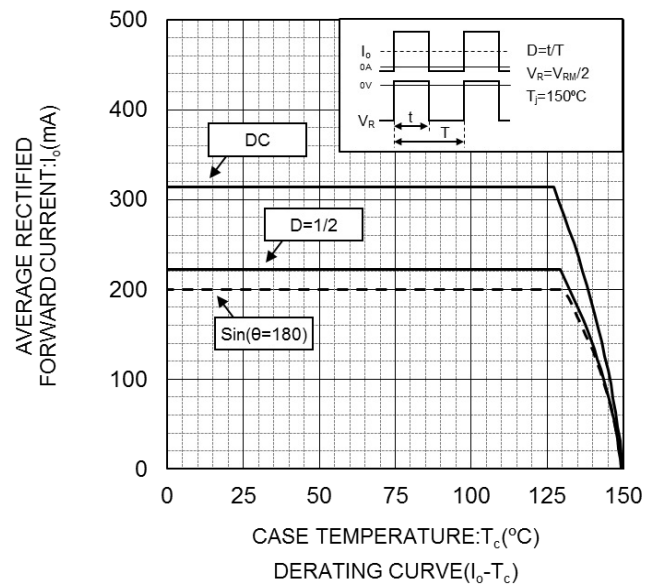
