Cleaning and Washing:

Storage Conditions:

 A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.

- Do not expose the components to direct sunlight.

- Stacking height of more than seven layers is not recommended.

Handling:

- Recommended use is between 10% and 30% material compression. Use of material beyond recommended compression rate may
 result in excessive silicone oil exudation.
- It is recommended to compress the material with equal pressure on the whole surface. Partial excessive stress may also result in
 excessive oil exudation.
