


Power Consumption



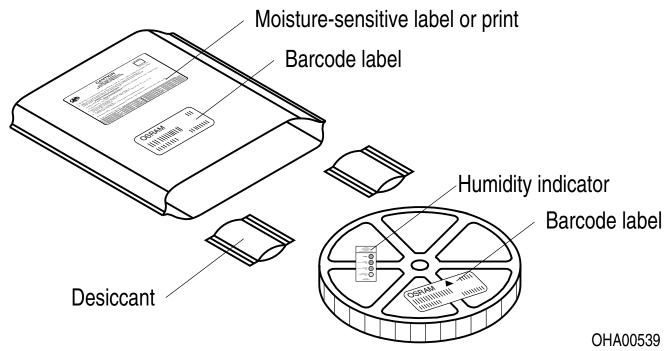
