

Total Power Dissipation vs. Ambient Temperature:







# Collector-Emitter Saturation Voltage vs. Ambient Temperature:



### Forward Current vs. Forward Voltage:



**Relative CTR vs. Forward Current:** 





# Switching time vs. Load Resistance:





## Gain vs. Frequency:




