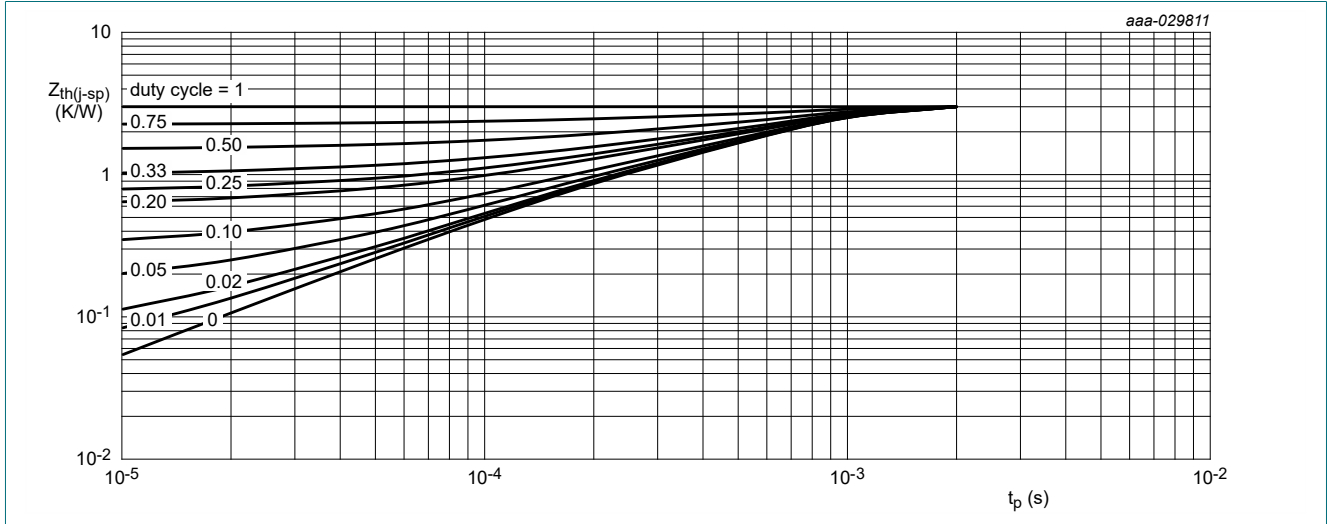
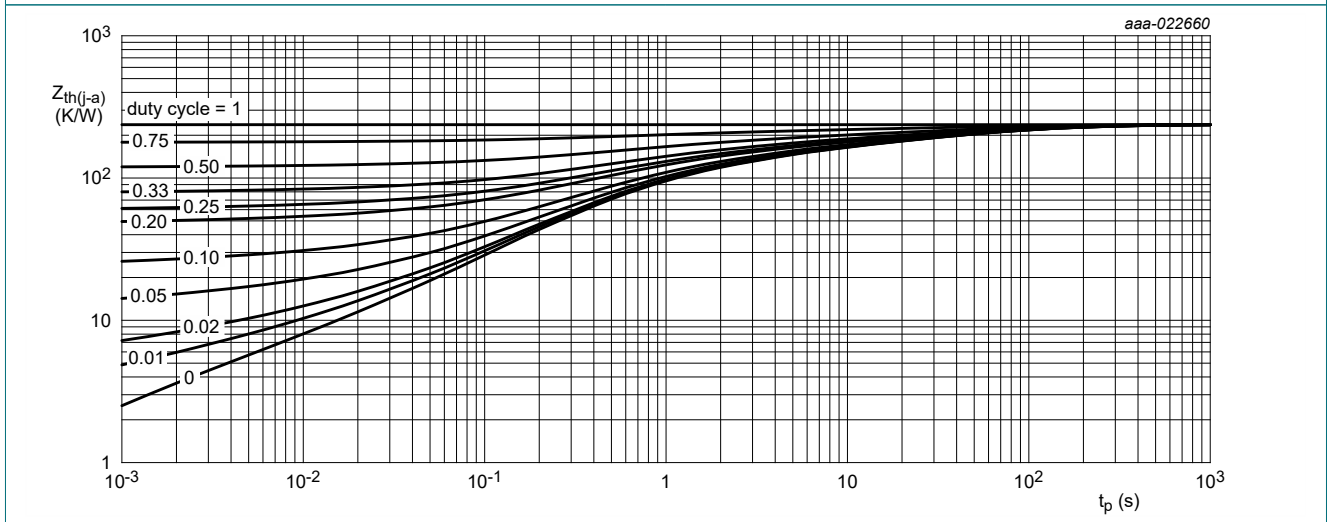


Fig. 4. Transient thermal impedance from junction to solder point as a function of pulse duration; typical values

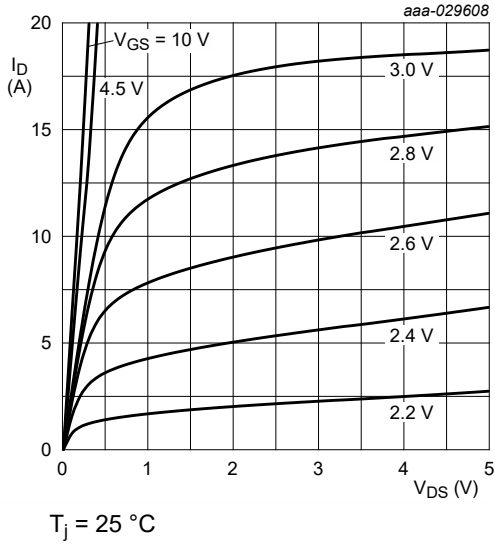


Fig. 6. Output characteristics: drain current as a function of drain-source voltage; typical values

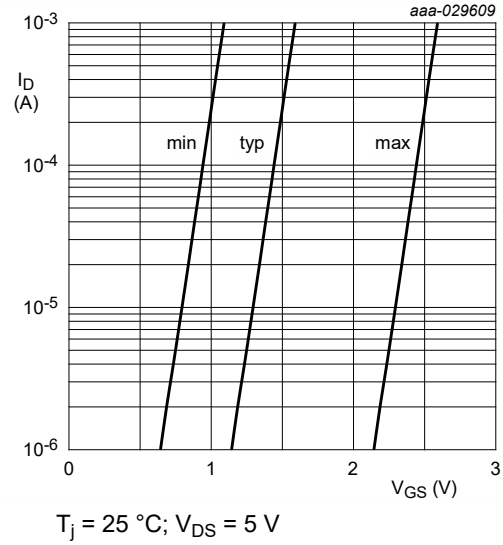


Fig. 7. Sub-threshold drain current as a function of gate-source voltage

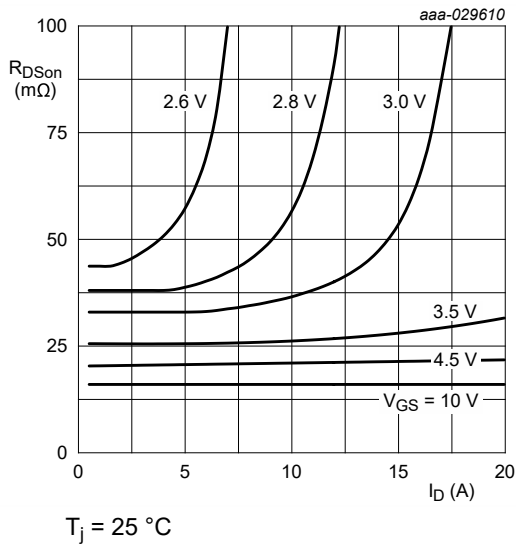


Fig. 8. Drain-source on-state resistance as a function of drain current; typical values

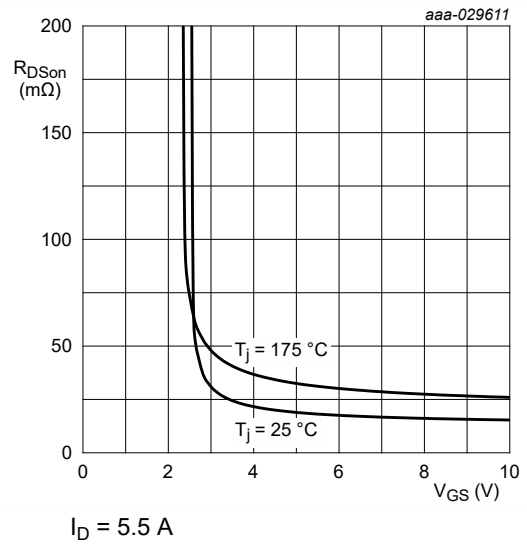
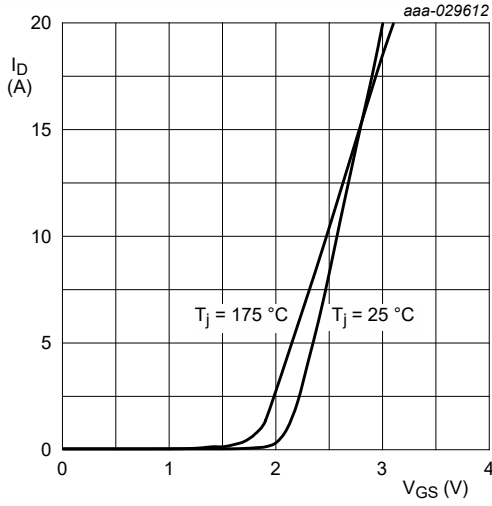
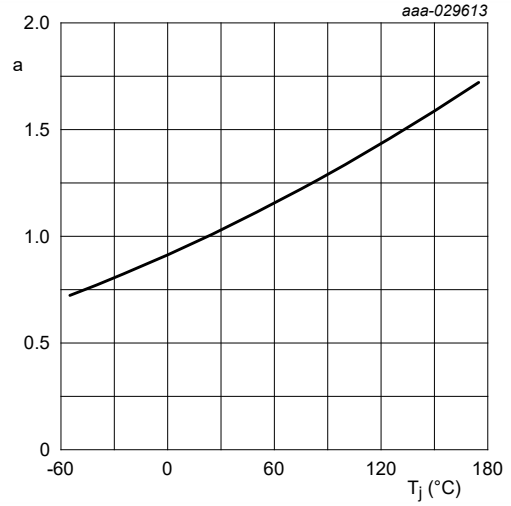


Fig. 9. Drain-source on-state resistance as a function of gate-source voltage; typical values



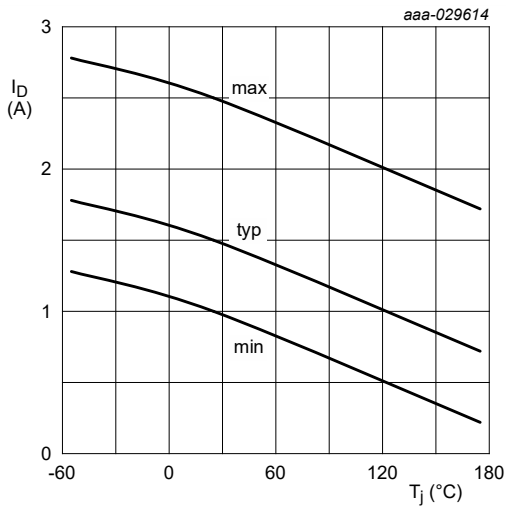

Fig. 10. Transfer characteristics: drain current as a function of gate-source voltage; typical values



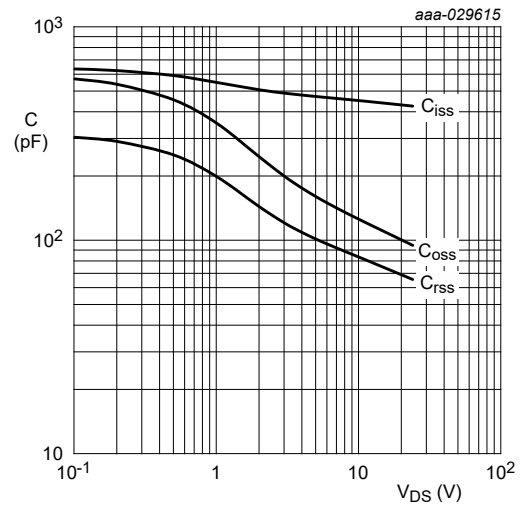

Fig. 11. Normalized drain-source on-state resistance as a function of junction temperature; typical values



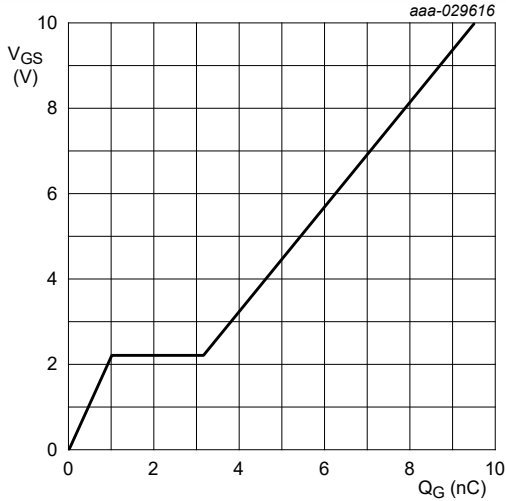

Fig. 14. Gate-source voltage as a function of gate charge; typical values

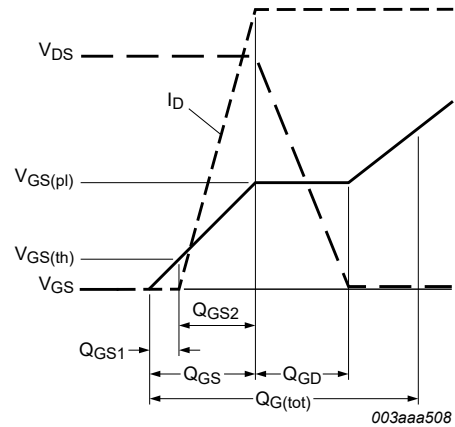
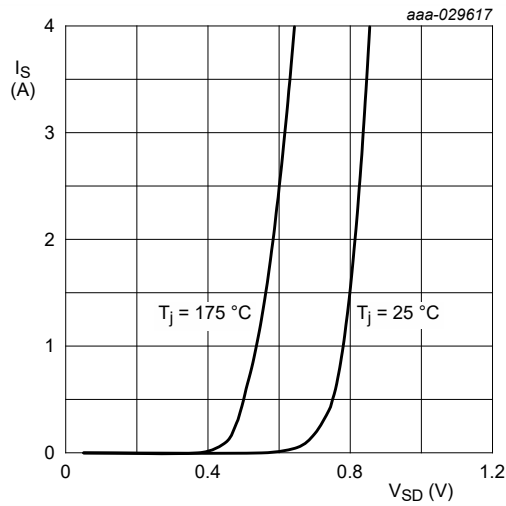


Fig. 15. Gate charge waveform definitions

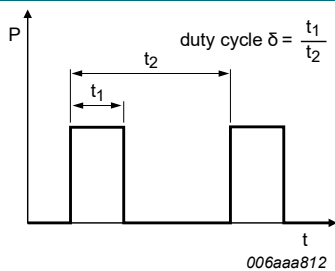


Fig. 17. Duty cycle definition

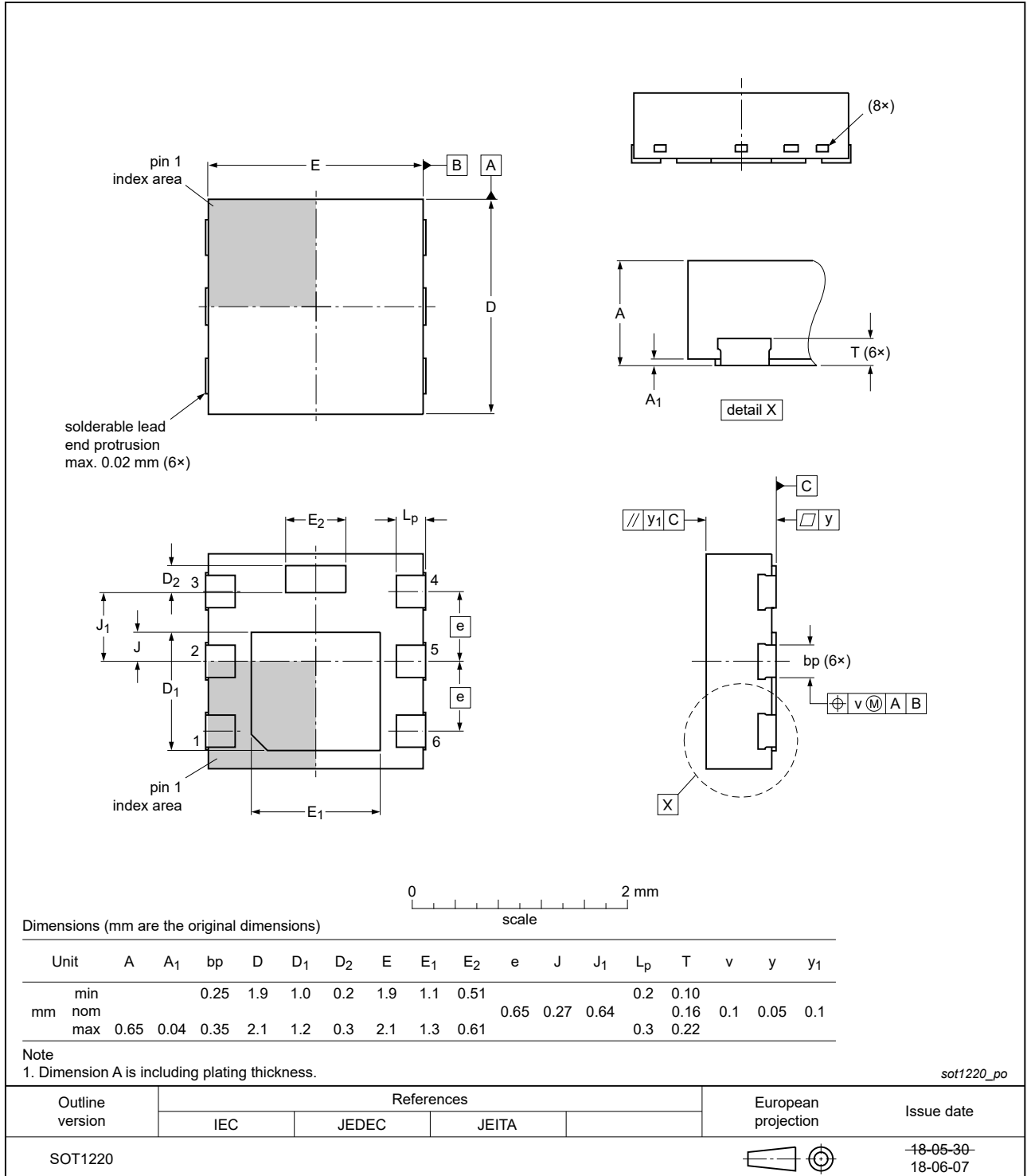


Fig. 18. Package outline DFN2020MD-6 (SOT1220)

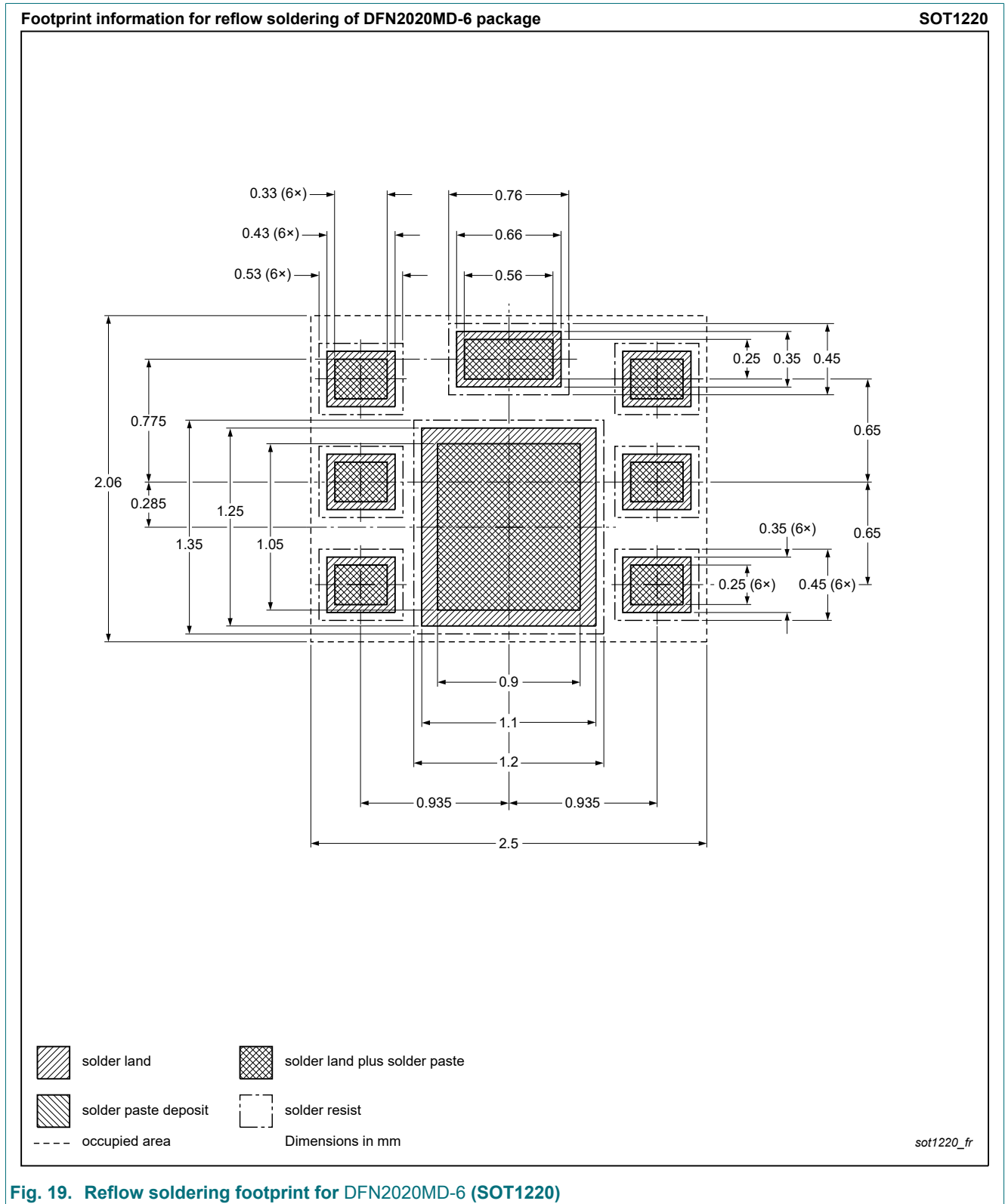


Fig. 19. Reflow soldering footprint for DFN2020MD-6 (SOT1220)
