Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

Cleaning and Washing:

Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the component. We recommend a
manual inspection after potting to avoid these effects.


Storage Conditions:
