#### Soldering

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

- Strong forces which may affect the coplanarity of the components' electrical connection with the PCB (i.e. pins), can damage the part, resulting in avoid of the warranty.

#### **Cleaning and Washing:**

### **Potting**

could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the component. We recommend a
manual inspection after potting to avoid these effects.


### **Storage Conditions:**
