


INA 180-INA 181 EVM



This user's guide describes the characteristics, operation, and use of the INA180-181 evaluation module (EVM). This EVM is designed to evaluate the performance of the INA180A1, INA180A2, INA180A3, INA180A4, INA181A1, INA181A2, INA181A3, INA181A4 voltage output current-shunt monitors in a variety of configurations. This document includes a schematic, reference printed-circuit board (PCB) layouts, and a complete bill of materials.

1 Overview

The INA180 family of current-shunt monitors (also called current-sense amplifiers) can sense drops across shunts at common-mode voltages from -0.2 V to +26 V, independent of the supply voltage. Four fixed gains are available: 20 V/V, 50 V/V, 100 V/V, and 200 V/V. The INA181 family has the same capabilities as the INA180 family but with the addition of the reference pin that enables bidirectional current measurements. These devices operate from a single 2.7-V to 5.5-V power supply, drawing a maximum of 260 μ A of supply current per amplifier channel.

The INA180 devices are currently available in a SOT23(5) and SC70(5) surface-mount packages in two common used Op-Amp pinouts and the INA181 devices are available in a SOT23(6) and SC70(6) surface-mount packages. Table 1 lists the available gain options.

2 INA180-181EVM Hardware

The INA180 is an Op-Amp current sense integration solution that provides ease of use and high performance. The INA181 has the same capabilities as the INA180 but with the addition of the reference pin that enables bidirectional current measurements. The INA180-181EVM is intended to provide basic functional evaluation of this device family. The fixture layout is not intended to be a model for the target circuit, nor is it laid out for electromagnetic compatibility (EMC) testing. The INA180-181EVM consists of one PCB with an option to cut out eight individual PCBs - one for each of the eight devices (INA180A1, INA180A2, INA180A3, INA180A4, INA181A1, INA181A2, INA181A3 and INA181A4).

2.1 Features

The layout of the INA180-181EVM printed-circuit board (PCB) is designed to provide the following features:

- Evaluation of all gain options for the INA180Ax and INA181Ax
- Ease of access to device pins with test points
- Capability to evaluate high-side and low-side configurations

See the INA180 and INA181 data sheets (SBOS741, SBOS793) for comprehensive information about the INA180 and INA181 family of devices.

3 Quick Start Setup and Use

The following are instructions to set up and use the INA180Ax devices of the INA180-181EVM. For the following instructions, x = 1 to 4.

- Step 1. Connect an external dc supply voltage between 2.7-V and 5.5-V to the Vs test point TPx01 or TPx11, and connect ground reference of that supply to the GND test point TPx05 or TPx15.
- Step 2. Connect the input per Section 3.1.

The following are instructions to set up and use the INA181Ax devices of the INA180-181EVM. For the following instructions, x = 5 to 8.

- Step 1. Connect an external dc supply volatge between 2.7-V and 5.5-V to the Vs test point TPx01 or TPx11, and connect ground reference of that supply to the GND test point TPx05 or TPx15.
- Step 2. The REF pin is connected to GND in the default board. The voltage applied at the reference input varies depending on how the device is going to be used. Further details regarding the use of the reference voltage are discussed later in this document.
- Step 3. Connect the input per Section 3.1.

3.1 Measurements

The INA180-181EVM enables the user to either simulate the voltage developed across a sense resistor based on a given set of system conditions or to connect remotely to an existing shunt already included in an example application.

The following procedures are used to configure a measurement evaluation without a shunt. For the following instructions, x = 1 to 8.

- Step 1. Connect a differential voltage to the IN+ (TPx02 or TPx12) and IN- (TPx03 or TPx13) test points. With the reference voltage set at ground, ensure that the IN+ pin is the more positive of the two inputs.
- Step 2. Measure the output voltage at the OUT test point (TPx04 or TPx14).

NOTE: The output voltage is equal to the gain of the device multiplied by the differential voltage measured directly at the device input pins.

4 INA180-181EVM Circuit

This section summarizes the INA180-181EVM components. For the following instructions, x = 1 to 8.

4.1 Cx01

Cx01 are 0.1-µF supply bypass capacitors.

4.2 Ux

Ux is the location for the test device. Eight device boards are supplied with the INA180-181EVM board. Each board is populated with one of the available device gains. This option enables users to test the devices and determine the gain setting that is best suited for a given application.

The following is a list of the factors involved in selecting the appropriate device:

- The INA180A1-A4 devices are identical with the exception of different gain settings. The INA181A1-A4
 devices have the same device gain options of the INA180 but with the addition of the reference pin that
 enables bidirectional current measurements.
- Select INA180 for unidirectional applications only, and select INA181 for unidirectional or bidirectional applications.
- The differential input voltage is applied across the inputs, or developed based on the load current that flows through the shunt resistor.
- The limiting factor that requires attention to be given to device selection is the output voltage.
- The selected device must allow the output voltage to remain within the acceptable range after the
 developed input voltage is amplified by the respective device gain. The output voltage must remain
 within the range of 10 mV above ground to 100 mV below the supply voltage.
- An output below the minimum allowable output requires the selection of a device with a higher gain. Likewise, an output above the maximum allowable output requires the selection of a device with a lower gain.

4.3 Voltages Inputs

The IN+ (TPx02 or TPx12) and IN- (TPx03 or TPx13) inputs accept a differential voltage that is amplified by the selected device gain and is presented at the OUT test point (TPx04 or TPx14). These inputs can also be used to connect the differential voltage developed across an external shunt in an existing circuit. The acceptable differential input voltage range and polarity are determined by the supply voltage, reference voltage, and gain of the selected device.

5 Reference Voltage Setup

The INA181A1-A4 devices enable the use of an external reference. This reference determines how the output responds to certain input conditions. The reference also enables these devices to be used in unidirectional and bidirectional applications.

5.1 Unidirectional Mode

Unidirectional refers to a load current that flows in only one direction.

The INA180A1-A4 devices are able to measure unidirectional currents only. The INA181A1-A4 devices measure unidirectional and bidirectional currents. The INA181A1-A4 boards in the EVM have the REF pin connected to GND through a 0-ohm resistor. This connection enables unidirectional measurements. If bidirectional measurements are needed, the INA181A1-A4 boards can be modified to add external voltages to the REF pin.

5.2 Bidirectional Mode

The INA181A1-A4 devices are able to measure bidirectional currents. *Bidirectional* refers to a load current that flows in both directions. The ability to measure this current flowing in both directions is enabled by applying a voltage to the REF pin. The voltage applied to REF sets the output state that corresponds to the zero-input level state. The output then responds by increasing above REF for positive differential signals (relative to the IN– pin) and responds by decreasing below REF for negative differential signals. This reference voltage applied to the REF pin can be set anywhere from 0 V to V+. For bidirectional applications, REF is typically set at mid-scale for equal signal range in both current directions. In some cases, however, REF is set at a voltage other than mid-scale when it is unnecessary that the bidirectional current and corresponding output signal be symmetrical.



5.3 REF Pin Configuration (INA181A1-INA181A4 Devices Only)

The REF test point (Tx06 or TPx16) enables the user to configure the INA181A1-A4 device boards for either unidirectional or bidirectional operation. INA181A1-A4 boards have a 0-ohm resistor that enables the user to use the boards for unidirectional or bidirectional measurements. If the 0-ohm resistor (Rx01) is populated, the REF pin will be connected to GND, and the INA181 can be used for unidirectional measurements. If bidirectional measurements are needed, the user must desolder the 0-ohm resistor (Rx01) and connect an external supply to the REF test point (TPx06 or TPx16).

6 INA180-181EVM Schematic and PCB Layout

NOTE: Board layouts are not to scale. These figures are intended to show how the board is laid out. The figures are not intended to be used for manufacturing INA180-181EVM PCBs.




Figure 1. INA180-181EVM Schematic

Figure 1 shows the schematic for the INA180-181EVM PCB.




Figure 2. INA180-181EVM Top Overlay




Figure 4. INA180-181EVM Top Layer

- 1. EVMs have no direct function and are not finished products. EVMs shall not be directly or indirectly assembled as a part or subassembly in any finished product. For clarification, any software or software tools provided with the EVM ("Software") shall not be subject to the terms and conditions set forth herein but rather shall be subject to the applicable terms that accompany such Software
 - 1.2 EVMs are not intended for consumer or household use. EVMs may not be sold, sublicensed, leased, rented, loaned, assigned, or otherwise distributed for commercial purposes by Users, in whole or in part, or used in any finished product or production system.
- 2 Limited Warranty and Related Remedies/Disclaimers:
 - 2.1 These terms do not apply to Software. The warranty, if any, for Software is covered in the applicable Software License Agreement.
 - 2.2 TI warrants that the TI EVM will conform to TI's published specifications for ninety (90) days after the date TI delivers such EVM to User. 3.4 European Union
