




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage






Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Allowable Case Temperature vs.
Average Forward Current




Fig. 5 - Thermal Impedance Z<sub>thJC</sub> Characteristics




Fig. 6 - Typical Reverse Recovery Time vs.  $dI_F/dt$ 




Fig. 7 - Typical Stored Charge vs. dl<sub>F</sub>/dt




Fig. 8 - Typical Recovery Current vs. dI<sub>F</sub>/dt




Fig. 9 - Reverse Recovery Waveform and Definitions




